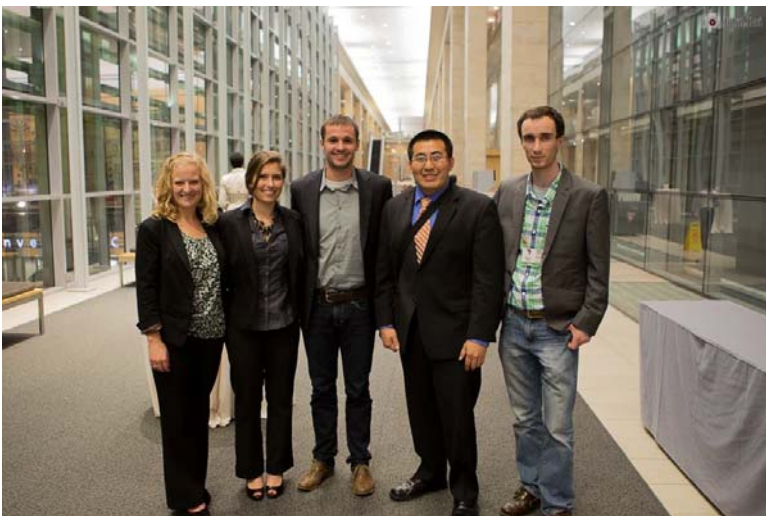
Dr. Dominique van der Mensbrugge will be joining the Department in July as Director and Research Professor, Center for Global Trade Analysis.

Managers Learn Sales Leadership Techniques at Center Program

Sales Management and Leadership, held May 28-29, at Purdue's Beck Agricultural Center, focused on preparing new sales managers for success. The program gave participants, 35 managers from across the United States and Canada, an opportunity to interact with one another and industry experts to learn advanced sales management and coaching techniques.

Dave Downey and Scott Downey led sessions including creating and managing culture and big data. Tom Dukes of Rhode Island College shared his perspective on sales psychology in a presentation entitled “Why Some People Achieve and Others Leave.”

Marj Shymske of RTP Consulting spoke to the group about her career in sales leadership, and Dave Kucik, Purdue’s crew coach, demonstrated successful coaching techniques in a presentation with student crew team members.

During an interactive “speed coaching” exercise, the group had a chance to practice the concepts they had discussed in the classroom. In a case study, participants looked at a company report and gave suggestions as to how the manager in the case study could improve his leadership. Participants were then greeted by a surprise guest, Sam Faggetti of WinField Solutions — Sam had been the manager in the case study all along.

17th Annual Conference on Global Economic Analysis

The 17th Annual Conference on Global Economic Analysis was held from June 18-20. The main theme of the conference was "***New Challenges in Food Policy, Trade and Economic Vulnerability***".

The annual conferences on global economic analysis are long-standing offerings of the Center for Global Trade Analysis which strive to promote the exchange of ideas among economists conducting quantitative analysis of global economic issues while becoming part of the international GTAP Network.

In total, 204 individuals from 47 different countries participated in this conference which was co-organized by the Center for Global Trade Analysis and [AGRODEP](#), facilitated by [IFPRI](#).
