On June 19, 2014, at the National Press Club in Washington, DC, Professor Emeritus **John M. Connor** will be the recipient of the **Alfred E. Kahn Award for Antitrust Achievement**, given annually by the American Antitrust Institute as its highest honor. (The award was renamed in 2011 to honor the recently deceased Kahn, the “godfather of deregulation.”)

Of the 16 past recipients, five are primarily academic scholars. The four previous economists honored are among the leading lights of the profession whose works have contributed to competition laws and enforcement. Scherer is the author of the dominant industrial-organization textbook during 1970-2000 and a prolific contributor to a wide range of issues in imperfect competition and antitrust economics. Kahn is best known for his research on the economics of regulation and his leading political-economic role in deregulating the U.S. airline and telephone industries. Salop is widely considered a leader of the Post-Chicago Antitrust Movement, with pioneering models of how sellers can exploit imperfect information by consumers, strategic entry deterrence, and strategies for raising rivals' costs. Noll is an expert in the economic analysis of public law (courts, administration, and statutory interpretation), antitrust and privatization, and the sports industry.

The seven regulators and lawmakers who have been honored were outstanding advocates for active enforcement of their competition laws who often designed and implemented effective new programs. The attorneys who were recognized also brought about advances in techniques for successfully securing damages in antitrust cases. Several of the regulators and attorneys were active writers of articles in law journals or popular books.

News from Patrick Hatzenbuehler and his travels to the Kano Dye Pits, Kano, Nigeria:

The Kano Dye Pits are sponsored by the Kano State Department of Tourism. The ingredients for the dye pits are dried indigo flower (for color), potassium (to make the dye saturate), and ash (to give the fabric a sheen). The ingredients are mixed with water, covered and left to ferment for about 4 weeks. One pit can be used for up to 8 months before being refreshed. To get a very dark color the dyers dip the fabric for up to 8 hours.
