Bulls were weighed on November 15 and 16 with the average weight between both days being the official on-test weight for the 2021 Winter Test. 175 bulls were received on delivery day; however, one bull was sent home 11 days post-delivery for poor disposition, therefore 174 bulls were weighed onto test. A receiving ADG of 2.3 lbs/day was a couple of tenths better than projected based on where intakes were at going into the on-test weight. As of the writing of this letter, bulls are four days out from being at full feed (2.5% BW on dry matter basis).

The initial 45 days at the test station are historically the most active in having health challenges. Myself and staff at FPAC were and remain aggressive in working at identifying bulls suspect of having bovine respiratory disease (BRD) in addition to other ailments. The table below provides a summary of health challenges amongst bulls between delivery day and the last bull stepping off the chute at the on-test weight's.

If one of your bulls received treatment, a summary of that treatment is provided in this mailing. Chloretetracycline was pulsed in the feed for 5 consecutive days following the on-test weights at the treatment dose of 10 mg/lbs of bodyweight. The week prior to Thanksgiving and through the Thanksgiving holiday new cases were sparse. Please contact me with any questions you have regarding the health of your bull(s).

A nutrient analysis of the on-test diet will be included in the next mailing following the 28-day weight.

## \*\* PLEASE REVIEW SUPPLEMENTAL MATERIAL INCLUDED \*\*

Experience leads me to encourage you to go ahead and have all bulls parent verified regardless of how they are performing. We have not completed a test where delayed parentage prevented a bull or two from selling.

Dates for carcass ultrasound scanning will be determined in the coming weeks.

Also, please know you as well as other cooperators or beef cattle producers are welcome to attend the board of directors meeting following the 28-day weight on June 15. I encourage you to do so if you have interest in being on the board at some point in the future.

Meeting time will begin shortly after we conclude taking the 28-day weight of bulls. Meeting location is to be determined, please reach out to me for that information if you plan to attend.
