#### Professor Earl W. Kehrberg, 97

Professor Earl W. Kehrberg, Ph.D., 97, of Otterbein, died, Wednesday, November 18, 2015. He was born September 30, 1918, in Aberdeen, SD, to the late Herman & Gladys (Weinheimer) Kehrberg. He married Norma (Hanson) Kehrberg, in 1945; she died, October 17, 1996. He graduated from Ortonville Minnesota Public Schools, in 1937, received his Teacher Training from St. Cloud State College, & received his B.S. from Iowa State University, in 1949 & his Ph.D. from Iowa State University, in 1953. He joined the Purdue Agricultural Economics staff in July, 1953 and retired in June, 1984. He taught courses and counseled students and faculty in the areas of production economics, statistics, and research methodology. He is remembered by his colleagues as a scholar's scholar. His research was concentrated in the area of production economics. He became assistant head for research in June, 1974, a position he held until February, 1983. He was a Visiting Professor, Universitat Hohenheim, Germany, July, 1961 -June, 1962; Visiting Professor, Universidade Rural do Estado de Minas Gerais (Now Universidade Federal de Vicosa), Brazil, South America., July, 1966 -July, 1968. Throughout his career he authored

& contributed to numerous books & research papers on Agriculture Economics worldwide. Earl was a WWII Veteran, with the United States Marine Corp., serving as an Airborne Radar Technician & was Honorably Discharged as a Technical Sergeant. He was a member of the American Agricultural Economics Association, American Statistical Association, Society of Sigma Xi, Phi Kappa Phi, Gamma Sigma Delta, Otterbein Rotary Club & Otterbein United Methodist Church, where he was active with the Men's Fellowship.

He is survived by 2 Sons, Lynn Kehrberg, Otterbein & Karl (Wife, Debi) Kehrberg, Miltona, MN, 5 Grandchildren & 11 Great-Grandchildren.

A Memorial Service was held at the Otterbein United Methodist Church, 405 East Oxford Street, Otterbein, Friday, November 27, 2015 at 2:30 PM, with Pastor John Randall officiating.

#### 2015-2 GTAP 101 Course

#### "Introduction to Computable General Equilibrium Modeling"

The <u>Center for Global Trade Analysis</u> recently held the second 2015 offering of its <u>GTAP 101 Course</u> from September 14 – October 30, 2015. GTAP 101 is an online course aimed to engage participants in an active, team-based process of learning about the GTAP computable general equilibrium (CGE) model and its use in applied economic policy analysis. During the course, participants:

- reviewed core economic theories from macro, micro, trade and public finance and observe how they are
  operationalized in an applied general equilibrium model;
- learned to recognize, control and interpret the theoretically consistent behavior of consumers and producers in the model;
- observed the aggregated, macroeconomic impacts of microeconomic behaviors;
- defined model experiments that represent real-world issues and problems; and
- learned to interpret general equilibrium model results by calling on and integrating their knowledge of multiple fields of economic study.

In total, 23 individuals from 16 different countries representing government agencies, international institutions, the private sector and academia participated in this course.
