# **Special Award:**

Purdue University, Department of Agricultural Economics alumnus **Akinwumi (Akin) Adesina**, president of the African Development Bank Group, has been named the 2017 World Food Prize Laureate for his work as a reformer and leader in the agricultural sector in Africa and internationally.

The World Food Prize, often referred to as the Nobel Prize for food and agriculture, is the highest international honor recognizing the achievements of those who have advanced human development by improving the quality, quantity of

availability of food in the world. **Dr. Adesina**, who was awarded an honorary doctorate from Purdue in 2015, earned his master's (1985) and doctoral (1988) degrees in agricultural economics from Purdue. After graduating, he returned to his home country of Nigeria, where he launched his career.

In 2015, **Dr. Adesina** was elected president of the African Development Bank Group (AfDB). The AfDB works to reduce poverty by spurring sustainable economic development and social progress in its regional member countries. Dr. Adesina was appointed Nigeria's Minister of Agriculture in 2011, and during his four-year term, he ended 40 years of corruption in the fertilizer sector by developing and implementing an innovative electronic wallet system that directly provides farmers with subsidies at scale using their mobile phones. Within the first four years after its launch, the electronic wallet system transformed the lives of 14.5 million farmers. Under **Dr. Adesina's** leadership, Nigeria's food production expanded by 21 million metric tons. Among other positions he has held were principal economist for the West Africa Rice Development Association; vice president of the Alliance for a Green Revolution in Africa; and regional director for the Southern Africa Office at the Rockefeller Foundation.

The 2017 World Food Prize Laureate Award Ceremony will be held on October 19 in the Iowa State Capitol Building in Des Moines. **Dr. Adesina** is the third Purdue Agriculture alumnus to receive the World Food Prize, joining Dr. Phil Nelson, Professor Emeritus of Food Science (2007) and Dr. Gebisa Ejeta, Distinguished Professor of Plant Breeding and Genetics and International Agriculture (2009).

This singular recognition of **Dr. Adesina** is most deserved, and for all of us in Purdue Agriculture it is truly exciting to anticipate what comes next as this very proud Boilermaker continues to invest his extraordinary leadership capabilities to end hunger and poverty in Africa.



#### 20<sup>th</sup> Annual Conference on Global Economic Analysis

The 20<sup>th</sup> Annual Conference on Global Economic Analysis was held from June 7-9, also on the campus of Purdue University. The overall theme of the conference was "*Global Economic Analysis in the 21<sup>st</sup> Century: Challenges and Opportunities*". The annual conferences on global economic analysis are long-standing offerings of the Center for Global Trade Analysis, which strive to promote the exchange of ideas among economists conducting quantitative analysis of global economic issues while becoming part of the international GTAP Network. In total, over 200 individuals from 33 different countries participated in this conference, which was organized by the Center for Global Trade Analysis in the Department of Agricultural Economics.
