## 5. Report on 2021 CISMA Conference Social Networking Session - Dawn Slack/Warner

- M. Warner found the meeting exceptional. Dan Shaver's presentation was outstanding.
- D. Slack Multi-day conference being with virtual network session; 6 recorded presentations with continuing education credits; Thursday was virtual conference with keynote by Dan Schafer and updates by state agencies; Ten Friday and Saturday field trips. Total attendees numbered 212. Virtual informational networking session of about 50 attendees resulted in a new Facebook page for CISMA leaders which was created by Indiana Invasives Initiative project. Objective for the creation of the Facebook page was a forum for administrative networking and idea-sharing. Hamilton County will manage this page.
- E. Barnes Also found the overall experience very good; even field visits with small numbers left members feeling inspired.
- E. Jacquart Fantastic, expanded, informational meeting.

# 7 Report on spotted lanternfly found in Indiana (E. Barnes)

- SLF detected in Switzerland County by a landowner.
- IDNR is surveying area to determine size of infestation. Response is being planned; may try eradication, but this has had low probability of success in other states.
- Source of the infestation has not been determined, however a local landowner recently relocated from Pennsylvania, an infested state.
- SLF may have a couple of years before critical mass is large enough to be conspicuous to public and economic concern. Public education of SLF issues and reporting occurrences are needed.
- Elizabeth Long, Purdue faculty and Specialty Crops specialist, is putting together a webinar for the grape/wine industry.
- SLF host plants to watch include wild and cultivated grapes, black walnut and tree-of-heaven.
- Education campaign Purdue Extension is working on a plan with IDNR.
- Penn State has best extension SLF info currently.

- Purdue Extension is developing a Public education campaign. Material containing look-a-like insects have been developed.
- S Yaninek suggested that since SLF may already be widely dispersing, eradication may not be a viable response. This highlights the importance of the ReportIN program in getting public assistance for detection. As Purdue Extension develops the response to SLF, the ReportIN 'tool" should be considered and utilized.
- M. Kraushar requests to be sent any social media posts or messaging on the SLF issue that IDOT may be able to assist in distributing.

# 8. Discussion of the Indiana Forest Forever (IFF) coalition information document on invasive species (M. Warner)

- The IFF coalition has a numerous and broad participant base. Information documents have been created on many forest environmental and management issues.
- The IFF invasive species information document is in development. This document could eventually be used in legislative negotiations on invasive species issues/needs/accomplishments.
- K. Werling requested D. Slack's perspective on idea that IFF would serve as an "umbrella" organization for IISC and CISMAs. Ans. M. Warner: To clarify, IFF does not want to be an umbrella organization. Some revision may be needed if that impression is evident.
- D. Slack The document prompted similar confusion and discussions with SICIM. Depending on future funding, SICIM is moving to becoming a state-wide organization, and not primarily centered on southern Indiana issues. The Indiana Invasives Initiative component has a state-wide focus which could lead into the "umbrella" organization concept.
- M. Kraushar Who are the expected audience/recipients of the document? Ans. This document is a call to action for all entities that have an interest in Indiana invasive species. Target audience includes legislators and conservation partners/member organizations.

- S. Yaninek Suggested adding recent and current specific examples of high-profile invasive species in Indiana; EAB, SLF, etc.
- D. slack reported that the III contract amendment allowing the addition of an executive director was approved and a candidate search is underway. Negotiations with NRCS for continued III funding have begun.

Representing Purdue University College of Agriculture:

#### S. Yaninek-

- E. Barnes Entomological Society of American is changing the common name of the gypsy moth
- S. Yaninek recent UN Interagency Working Group on Climate Change Report should be a cause for concern for many reasons including particularly because of the increase in possibilities and opportunities for invasive species.

- Trevor Laureys, is the new Director of Division of Soil Conservation, ISDA; Jennifer Thum, is the new Deputy Director of the Division of Soil Conservation, ISDA.
- M. Warner suggested that one or both be invited to a future IISC meeting.

#### Represent INDOT (M. Kraushar)

#### Representing Horticultural Industry (R. Haggard)

- *Euonymus alatus* is on an advisor list in Indiana, however Knox County and the city of South Bend have local ordinances/restrictions. Currently only one variety is prohibited (*E. fortunei*), but others are on the list of highly invasive species.
- Question: (M. Warner) Are the Terrestrial Plant Rule details presented/discussed at industry meetings and publications? Ans. Yes.

## Representing Fish & Wildlife-Terrestrial Invasive Species (D. Keller)

- Asian carp as a collective term is now renamed invasive carp. This term includes grass, silver, big head, and black carp.
- Invasive carp coordinator recently left the IDNR, but did hire a new invasive carp biologist before leaving. Two additional biologists will be hired.
- Best Management Practices for invasive species management on public land are being constructed.

 An invasive species "bioblitz" event is being planned at Wilber Wright F&W Area at the end of September in collaboration with CISMA staff. A date for a similar event is being determined for Little Pidgeon F&W Area.

# Representing Indiana Dept of Transportation (M. Kraushar)

## Board of Animal Health: (K. Werling)

- No new domestic diseases to report
- Six suspected disease investigations (pig-4, rabbit-1, cattle-1) with all samples negative.
- Many reports of wild songbird deaths received this summer; BOAH handles domestic bird and IDNR
  handles wild bird reports but both agencies collaborate; all samples negative for Avian Influenza and
  virulent Newcastle disease; still no idea on cause of songbird deaths
  - o Cicadas and bird deaths? No conclusive evidence and considered very unlikely.
- African Swine fever still no detections in US, but found in across Dominican Republic. Importation of
  dogs and associated bedding from ASF countries have greater scrutiny and control to prevent movement of
  ASF agents.
- Chronic wasting disease a problem in Minnesota, but not in Indiana. Advanced planning for potential CWD response in Indiana is underway.

## Representing Indiana Department of Natural Resources' Division of Fish and Wildlife (Eric Fischer)

- The Indiana Invasive Aquatic Species Management Plan is now on the agency website.
- Kudos to D. Slack and M. Abraham for the recent CISMA conference. Greater interaction by Division F&W with the CISMAs is anticipated.
- Indiana State Fair IDNR activities are underway.
- A coordinated regional, invasive species boater blitz occurred over the 4<sup>th</sup> of July weekend.

#### Representing Indianapolis Dept of Parks and Works (L. Broadfoot)

## Representing Division of Entomology and Plant Pathology (M. Abraham/Phil Marshall)

- Gypsy moth surveys and treatments completed for the year; had significant defoliation in some locations (estimated 685,000 acres affected) DeKalb, Allen, LaPorte, Noble. Chain-O-Lakes State Park will be surveyed and treated next year if needed.
- Future direction maybe to instruct landowners to treat their private land for gypsy moth instead of a state-managed suppression program. Natural control with egg parasites, fungal *Entomophaga spp*. and nuclear polyhedrosis virus has been significant. These agents combined may reduce the impact of gypsy moth in 2022.
- Oak wilt is confirmed in Franklin County.
- Insecticide treatment is being considered to manage SLF in Switzerland County.
- Study of chestnut oak mortality in Yellowwood State Forest is underway.
- Patoka Reservoir forest health treatment will occur soon.
