## *Pest Management and Lawn Maintenance: A Workshop for Lawncare Professionals*

### About the Workshop

This hands-on program will include instruction to assist lawncare business owners. Topics include: basic turf maintenance, turf pest management programs, calibration and use of turf pesticide application equipment, and rules and regulations specific to lawncare applicators.

The program will begin at 8:30 a.m. (EST) and end at approximately 4:00 p.m. on both days, in the William H. Daniel Turfgrass Research and Diagnostic Center. The center is located north of the Purdue West Lafayette campus at 1340 Cherry Lane. Recertification credits (CCH's) will NOT be awarded.
