The Department of Natural Resources (DNR) has an exciting opportunity within our Northeast Region. Northeast Region is actively seeking a **Prevention and Fuels Assistant Fire Management Officer (Wildland Fire Management Specialist)** for the Arcadia Fire Control program. This position is based out of Deer Park, WA. The district consists of diverse fuel types that range from agriculture/shrub, steppe/dry

ponderosa pine to hemlock/subalpine fir forests.

The Arcadia District is responsible for wildfire suppression, prevention, and regulation on all or parts of four counties (Spokane, Pend Oreille, Stevens, and Lincoln) including one hundred thousand acres of state trust land. The Arcadia District conducts suppression actions on approximately 300 fire starts annually, processes approximately 400 burn permit requests, and provides training courses to our local cooperators. A large part of the Arcadia District is located in the Wildland Urban Interface of the greater Spokane area. Interagency cooperation occurs on the majority of the wildland fires and in most fire training courses in the Arcadia District. Interagency cooperation includes working with local fire districts, and state and federal partners and is a key function of the position.

Duties

Responsibilities:

Under the direction of the Arcadia Fire Management Officer, the Assistant Fire Management Officer of Prevention and Regulation has great influence on the quality, image, and message delivered to the general public of Washington State. This position works closely with stakeholders and other agencies and plays a leadership role in fire suppression activities, fire prevention education, and forest fuels reduction.

The majority of the duties will include coordinating and supervising fuels reduction projects, working with agency partners to coordinate fire prevention activities in the local communities, and fire suppression. This position will act in several different fireline roles depending on the need for the incident. A portion of this position's duties will be in an office setting reviewing burn permits, investigation reports, and planning for current and future fuels reduction projects or prevention activities. This position will supervise two permanent employees year round and up to 20 during winter fuels project months.

Other duties will include but are not limited to being a lead and/or unit instructor for NWCG fire courses for wildland fire training, and leading and participating in wildland fire prevention activities. The Arcadia District is a fast-paced and complex work environment that requires an individual who will work within the team's goals and dynamics to be successful.

This position works closely with three other Assistant Fire Management Officers in the District to accomplish the goals of the District, Region, and Department.

- The position's assigned duty station is the Deer Park work center. This
 position will spend 50% of the time working in the field either for wildfire
 response, fuels project management, or regulation visits, as well as 50% of
 time in an office setting coordinating prevention activities, writing burn
 permits, writing investigation reports, and participating in meetings.
 Incumbent must be able to traverse uneven terrain in all weather conditions.
- The position requires time in the field traveling alone between fires, work centers, prevention activities, job sites, and burn permit locations. This includes driving on icy and snow-covered roads, during low visibility conditions and stormy weather possibly at night.
- A valid unrestricted driver's license and have two years of driving experience.
 This position requires driving as an essential function. Finalists and/or interview candidates will be asked to provide a driving record from all states in which they have held a license during the past three years.
