### **Summary:**

This position will be based out of the Crater Lake-Klamath Falls Regional Airport, Kingsley Field OR Air National Guard. The Position will be responsible for assisting the ANG Wildlife Biologist in implementing the Wildlife Hazard Management Plan, and BASH plan. This positions primary

responsibilities are to reduce wildlife hazards to air safety at Kingsley Field. This position may be asked to perform similar duties at other airports as well as conflict prevention work within Klamath County as supported by the District Supervisor(s) and State Director. Additionally, may be asked to perform other field duties as assigned.

#### **DUTIES:**

Responsible for assisting in organizing and conducting direct control operations to reduce wildlife damage at the Crater Lake-Klamath Falls Regional Airport, Kingsley Field OR.

Responsible for assisting in organizing and conducting direct control operations to reduce wildlife damage within a geographical area or technical/subject area of program involvement as needed when deemed necessary by the supervisor.

Assist as needed with monthly surveys at the Crater Lake-Klamath Falls Regional Airport, Kingsley Field, and surrounding areas.

Assist with writing quarterly reports of wildlife management activities at the Crater Lake-Klamath Falls Regional Airport, Kingsley Field. Individual will also attend quarterly AOB meetings with Airport Operations staff, and ANG personnel to update on current wildlife activities and concerns.

Inspects and surveys areas and, as necessary, will revise existing Wildlife Damage Management (WMD) activities in close consultation with higher-level management.

Performs duties relating to wildlife damage management and the use of non-lethal predator damage management techniques and procedures for the purpose of reducing predation on livestock and damage to property.

Skilled in use of firearms, traps, snares, pesticides, pyrotechnics, electronic harassment devices, and other wildlife damage management tools.

Participates in required training, e.g. computers, predator damage management techniques, all-terrain vehicles (ATV), and related equipment utilized in wildlife damage management operations.

Incumbent is entrusted with, and is responsible for, Government-owned control equipment for which an inventory must be maintained and reported, including locations, acquisitions, returns and losses.

Independently determines and selects the most effective means of addressing conflicts for individual situations.

Modifies or adapts established WMD techniques as necessary to meet local conditions and address specific environmental, economic, or political considerations

Assists in the negotiation of cooperative service agreements with landowners, lessees, or administrators to accomplish the goals outlined for the WS program.

Enters data into established WDM database/system of record. Uses data to prepare and submit routine reports regarding daily, weekly or monthly activities, observations, and events.

Complies with restrictions and mitigation measures established through consultation with relevant Federal and State agencies.

Monitors and ensures compliance with federal, state, and local regulations; assists airports with compliance with the Migratory Bird Treaty Act (MBTA), Endangered Species Act (ESA), Federal Aviation Regulation (FAA), Air Force Instruction (AFI), and other DoD regulations.

Carries out duties in accordance with program decisions made in compliance with the National Environmental Policy Act (NEPA), Endangered Species Act (ESA), and departmental and agency directives, laws, and regulations under guidance and oversight by a supervisor.

Performs other duties as required.

## MINIMUM ELIGIBLITY REQUIREMENTS:

To qualify, applicants MUST meet all minimum qualification requirements, except Medical Requirements, by the closing date of the announcement.

### **QUALIFICATIONS REQUIRED:**

### For the GS-4 Grade Level:

Applicants must have 6 months of general experience and 6 months of specialized experience (equivalent to the GS-03 level) that may have been obtained in the private or public (local, county, state, Federal) sectors which demonstrates:

- Ability to identifying North American wildlife species.
- Experience with firearms.
- Ability to meet and communicate with individuals and groups.
- Experience with computers, word processing, spreadsheets, and data bases.

#### OR

**Education Substitution at the GS-4 Grade Level:** Successful completion of 2 years of study that included at least 12 semester hours in any combination of courses such as biology, chemistry, statistics, entomology, animal husbandry, botany, physics, agriculture, or mathematics. At least 6 semester hours of courses must be in wildlife.

#### OR

### **Combination of Education and Experience at the GS-4 Grade Level:**

Applicants may have combinations of successfully completed education and specialized experience to meet total qualification requirements. The total percentages must equal at least 100 percent to qualify for that grade level.

### For the GS-5 Grade Level:

Applicants must have one year of specialized experience (equivalent to the GS-4 level) that may have been obtained in the private or public (local, county, state, federal) sectors which demonstrate experience in:

- Experience in wildlife damage mitigation methods and techniques
- Experience using lethal and non-lethal animal control techniques
- Experience recognizing and accurately identifying damage caused by various wildlife species and selecting appropriate species-selective management actions.

#### OR

Successful completion of a full 4-year course of study leading to a bachelor's degree with major study, or at least 24 semester hours, in any combination of scientific or technical courses such as biology, chemistry, entomology, animal husbandry, botany, physics, agriculture, or mathematics, with at least 6 semester hours in wildlife.

#### OR

## **Combination of Education and Experience at the GS-5 Grade Level:**

Applicants may have combinations of successfully completed education and specialized experience to meet total qualification requirements. The total percentages must equal at least 100 percent to qualify for that grade level.

#### For the GS-6 Grade Level:

Applicants must have one year of specialized experience (equivalent to the GS-5 level) that may have been obtained in the private or public (local, county, state, federal) sectors which demonstrates experience in:

- Dealing with human-wildlife conflicts and principles of wildlife damage management.
- Experience safely and effectively using firearms, traps, snares, pesticides, immobilizing drugs, pyrotechnics, electronic harassment devices, and other non-lethal control tools to provide wildlife damage management to cooperators.
- Creating/maintaining public contacts to formulate assistance strategies that incorporate technical assistance and operational control techniques.

#### OR

Successfully completed 1 year of graduate education (18 semester hours) in wildlife.

#### OR

### **Combination of Education and Experience at the GS-6 Grade Level:**

Applicants may have combinations of successfully completed education and specialized experience to meet total qualification requirements. The total percentages must equal at least 100 percent to qualify for that grade level

## HOW YOU WILL BE EVALUATED

Applicants who meet basic minimum qualifications may be referred to the hiring manager for selection. Qualified candidates eligible for veterans' preference will receive referral and selection priority over non-veterans.

### **OTHER REQUIREMENTS:** (if applicable to your position)

- Must obtain or have a valid state driver's license. Operation of Government-owned or leased vehicles is required. (if this applies)
- As a condition of employment, appropriate security clearance is required for this position.
- Position is subject to random and applicant drug testing.
- Must demonstrate a respect for safety in all operations, including the operation of motor vehicles, firearms, control devices, and equipment.
- In order to perform the essential duties of this position, you must have the legal and physical ability to possess and discharge firearms. You must be able to pass a government background check and meet any additional requirements to carry and use firearms. A background check will include answering questions about where you've lived, worked, went to school, and any military history or police records. Selection and retention in this position is contingent on a successfully adjudicated FBI National Criminal History Check (fingerprint check).
- As required by the President's Executive Order 14043, Federal employees are required to be fully vaccinated against COVID-19 regardless of the employee's duty location or work arrangement (e.g., telework, remote work, etc.), subject to such exceptions as required by law. If selected, you will be required to be vaccinated against COVID-19 and submit documentation of proof of vaccination before appointment or onboarding with the agency. Additional information will be provided regarding what information or documentation will be needed and how you can request of the agency a legally required exception from this requirement.

Emergency Response – APHIS is an emergency response agency. This means that all Agency employees may be asked or assigned to participate in rotating temporary duty assignments to support emergency programs at some time during their careers with APHIS. It is difficult to predict the frequency with which such emergency situations may occur – and could range from several emergencies in a year to none over the course of many years. In the event that you are called upon to support an emergency program, this may require irregular working hours, including overtime, and may include duties other than those specified in your official position description. While some emergency program support assignments may be able to be performed at the employee's current duty station, in other cases employees may be asked to go on-site to a temporary duty state location. In addition, it may be necessary for employees to participate in multiple rotations to an emergency program assignment. Attempts will be made to keep disruption to the employee to a minimum.

NOTE: APPLICANTS FOR THIS POSITION WILL BE REQUIRED TO SUBMIT TO URINALYSIS TO SCREEN FOR ILLEGAL DRUG USE PRIOR TO APPOINTMENT. Carrying a firearm is a condition of employment – In the passing of the Lautenberg Amendment, Congress passed legislation which prohibits anyone who has been convicted of a misdemeanor crime of domestic violence from possessing a firearm or ammunition. If selected you will be required to

sign the form, "Inquiry for Positions Requiring Possession of Firearms," certifying that you meet this criteria.
