Course Equivalency Information

The form on the reverse is designed to establish agreement—prior to studying abroad—on how Purdue University will evaluate coursework completed overseas. It is important that this form be completed by any student who must enroll in specific overseas courses and/or have these courses used in their Purdue plan of study in some specific manner. By completing this form, you will insure the number of Purdue credits and the Purdue course number/title that will be assigned to overseas courses, as well as how your advisor will use these credits in your plan of study.

All courses completed while studying abroad on a Purdue study abroad program (even if you choose not to complete this form or if you change the courses listed) will be evaluated upon receipt of an official transcript from the cooperating overseas institution. Generally, this evaluation will result in both credits and letter grades being posted to the student's Purdue transcript. The number of Purdue credits and the letter grade recorded on the Purdue transcript for overseas courses are determined on a case-by-case basis, using standards established by Purdue University for each study abroad program. The student's advisor, following Purdue and College of Agriculture curriculum policy, will then determine how specific courses will be used in a student's plan of study.

Tips on Course Equivalency

- 4 If you plan to complete only elective courses while abroad, it may not be necessary to complete this form. Be aware, however, that most institutions abroad will ask you to indicate courses in which you plan to enroll.
- 4 Even if you change your overseas enrollment and complete courses not listed on this Course Equivalency Form, these courses will still "count" for Purdue credit and grades. This does not, however, guarantee that the overseas coursework will fulfill specific requirements in your Purdue plan of study, unless you work with your advisor to revise this form.
- 4 If necessary, this Course Equivalency Form can be revised at any time—even while you are overseas—by contacting your advisor and Agriculture Study Abroad.
