Position Summary

In conjunction with the Equestrian Director and Assistant Equestrian Director, the Equestrian Camp Counselor/Riding Instructor acts as a counselor in an Equestrian cabin (ages 11-15) and as an instructor giving safe and fun lessons that help facilitate personal growth in each camper and in their riding ability and relationship with horses. Able to execute safe programming, both at the barn and around camp, with a co-counselor.

ESSENTIAL DUTIES AND RESPONSIBILITIES

The essential functions include, but are not limited to the following:

- Instruct and/or assist in program/clinic areas as assigned, making curriculum cover all ages and skill levels
- Assist in the teaching of riding classes (English/Western) and ground school at the EQ center
- Assist with EQ afternoon clinics
- Be friend and leader to each individual in your cabin group to promote improved camper self-image and good group relationship
- Instruct and/or assist in program/clinic areas as assigned, making curriculum cover all ages and skill levels
- Maintain personal health including good hygiene and proper sleep. Interpret health and safety regulations to the group
- Observe each camper daily and check for cuts, bruises, skin rashes, or other indications of illness or injury
- Supervise and assist the group in cabin shared responsibility duties (camp clean-up)
- Offer guidance in cabin group, unit, and camp-wide activities
- Prepare parent letters as required & EQ blurbs
- Promote good manners at mealtime and encourage common courtesies in serving, passing, and eating food
- Establish schedule for campers to wash before meals and shower before devotions
- Provide cabin devotion each evening related to group interactions and needs (story, poem, discussion, prayer), and in keeping with the established camper is getting full benefit of this period of relaxation
- Be in the cabin with campers all night unless another individual is assigned
- At all times be aware that you are a "model" to all campers and to other staff. No drinking, smoking, or drugs at any time. Adhere to camp's personnel policy by following and enforcing camp rules

- Be at the cabin at all times on camper registration and departure days to ensure full counselor-parent communication at beginning and end of session
- Set a positive example in exercise, food selection, personal habits, and attitude
- Perform other functions as directed for the good of camp and the campers

PHYSICAL DEMANDS AND WORK ENVIRONMENT

Work Environment

- Ability to work indoors/outdoors, in the rain, wind, and in hot or cold conditions. Employee may be exposed to wet and/or humid conditions
- Ability to work in a hay and dust filled environment
- May be required to use personal protective equipment

Physical Demands

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of the job.

- Must be able to lift, bend, twist, stoop, climb, and have good hand dexterity
- Ability to push and pull loads

- Good physical health including ability to lift and carry objects up to 30 pounds in weight
- Must be able to assist people on/off horses
- Must be able to stand/walk for 8-10 hours per day
- Will be required to work more than an eight-hour day
- Must be able to saddle a horse
- While performing the duties of this job, the employee is regularly required to communicate and converse with employees, maintain a stationary position (standing and sitting), move/traverse, kneel, bend, and reach with hands and arms for extended periods of time.
 The worker may be required to operate in close quarters,

Hazards

The employee in this position may be exposed to certain hazards as part of the duties and responsibilities of the position such as animals, insects, poisonous plants, construction, heavy machinery and noisy environments, driving and working in adverse weather conditions, and the possibility of being a lone worker.

Required PPE

Camp Tecumseh will provide the required personal protective equipment (PPE) needed to mitigate or eliminate these hazards and all employees will be trained on the appropriate use of PPE.

- Helmet
- Pants (when riding a horse / not provided by the organization)
- Closed toed shoes (when riding a horse / not provided by the organization)

Position Type

This is a full-time, seasonal position. Days and hours of work are generally Sunday afternoon through Saturday morning; weekday hours are 7:00 a.m. to 6:00 p.m. (excluding Friday, will work until 10:00 p.m.). but is flexible based on need. Evening, night, and weekend work may be required as duties demand.
