Fulbright US Scholar Awards

1. Fulbright US Scholar Award Program AY 2023-24

- Over 900 **2 to 12 month** research, teaching, research/teaching awards in over 130 countries; must have US citizenship. See <u>https://awards.cies.org</u>
- Awards announced Feb. 2022 with an online application deadline of Sep. 15, 2022
- There are 43 awards in Agirculture with **191** "All Discipline" awards.
- Flex Option: allows for multiple visits to same country over two years.
- **Global Scholar Award:** allows for multiple visits to 2-3 countries (3 to 6 months total with a minimum of one month spent in each host country, each visit; only available in designated countries).

• <u>Recent Purdue Awardee</u>: Levon Esters, Department of Agricultural Sciences, Communication, and Education, Research Award to the University of Southern Queensland, Australia, 2020-2021 for "A USA-Australia Nexus Approach to Expanding Access to Tertiary and Career Education: A Vocational Psychology of Agriculture Perspective."

Fulbright Scholar Award Timeline

Successful applicants typically work **two years** backwards from the AY they plan on arriving in the host country. If you plan to be in Spain in Fall 2023, the process should begin now.







What's New for Fulbright Scholar Awards?

- 1. What's New for Fulbright Scholar Awards 2023-24?
- Only 2 LORs needed for application
- New website now lists host country contact information if you have questions; see https://awards.cies.org
- Awards now designate career profiles into early (<7 yrs), mid (7-13 yrs), and senior (>13 yrs) to clarify what had been murky about those designations.
- Fulbright now emphasizing dependent support; approximately 60% of Scholar awards provide dependent support
- New awards in Cape Verde and Maldives!
- Brazil has several new Distinguished Scholar Awards (esp in STEM areas)
- Canada now offers approximately 50 fellowships

Syllabi/course outlines	Required for Teaching and Teaching/Research awards, up to 10 pages
Letter of Invitation from host institution	Only if required or recommended by award description
Language proficiency	Only if required or recommended by award description
Digital Portfolio	Digital Portfolio Only for applicants in the creative/performing arts. Portfolios are limited to no more than 10 images, 15 pages in length or 30 minutes of audiovisual files.

PROCEDURES FOR FULBRIGHT AWARDS

Eligibility. All full-time Purdue West-Lafayette faculty are eligible to receive academic year salary support ("top-off") for Fulbright Core US Scholar Program Awards (other Fulbright awards such as the Fulbright Specialist Program, Fulbright Visiting Scholar Program, International Education Administrators Program, and Fulbright Nexus Program are not eligible).

Funding: Top-offs are subject to the review and approval of the Dean (with the expectation of approval) and should whenever possible be approved in advance of an external application or award. Approval will guarantee that the College will make up the difference between the award amount and the faculty member's AY base salary, while continuing to provide the associated/prorated benefits. The funding is a part of the budgeted salary held by the department/college.

Benefits. Leaves resulting from Fulbright US Scholar Programs will be handled as research/engagement leaves with partial pay or without pay (depending on the amount of funding received from Fulbright). A Fulbright fellow keeps all benefits even when he/she falls below 50% FTE at Purdue; in particular, health benefits are maintained with both the university and employee paying their share. Retirement benefits will continue only on the Purdue paid portion of the leave.

Process: Once the faculty member receives the award, they should share the Fulbright award document with their Business Office, Department Head, and Dean. Fulbright Scholar Awards should be taken in conjunction with sabbaticals whenever possible and would then follow university sabbatical guidelines (total compensation cannot exceed the full-time salary rate for the period of the leave). When the leave doesn't coincide with a sabbatical, the salary amount not covered by the award will be covered by the Department/College. The appropriate FTE will be calculated and submitted on the Request for Research Leave of Absence.









2. Fulbright Specialist Program

- Program was suspended due to COVID, but has now re-opened.
- Program pairs highly qualified U.S. academics with host institutions abroad to share their expertise, strengthen institutional linkages, and gain international experience.
- Eligible disciplines include:, Agriculture, Education (very broadly conceived), and Environmental Science.
- There are **no specific awards**, just **projects** which are funded.
- Funded projects are for 14 to 42 days (2-6 weeks) over a period of 1 to 2 years.

• Faculty apply to be named to the Fulbright Specialist Roster. If selected, they are on the roster for a period of 3 years and can then be paired either with **open projects** from host institutions around the world or with a **specific project** developed by the specialist with an international colleague/host institution in advance.

• **Recent Grantees in Agriculture**: Amanda Deering, Specialist Grant to Tajikistan for "Improving Food Technology and Food Safety Education in Tajikistan" (2020) and Kwamena Quagrainie, Specialist Grant to Ghana for "Incorporating Economic and Quantitative Assessments into the Aquaculture Academic Programs at Kwame Nkrumah University of Science and Technology" (2019).





Fulbright Specialist Program Benefits

• **Costs are shared** between Fulbright and host institution, host country education agency. Fulbright supplies roundtrip airfare, local transport to airport, and a stipend for the specialist. Host institution supplies local transport, per diem, and housing for the specialist.

Benefits for Participating Specialists

The U.S. Department of State

provides funding for round-trip economy class international airfare, a transit allowance (\$100), daily honorarium (\$200), and a limited health benefits plan

Host institutions provide lodging, meals, and in-country transportation for the duration of the grant period

What kinds of projects are funded?

- Delivering a seminar or workshop
- Consulting on faculty or workforce development
- Developing academic or training curricula and materials
- Lecturing at the graduate or undergraduate level
- Conducting needs assessments or evaluations for a program or institution

What You Cannot Do On A Project

- Teach a course
- Conduct research



What is the application timeline?

- 1. Faculty member applies to be named to Fulbright Specialist Roster
- 2. Get project approved by host Institution/Host Country
- 3. Eligible individuals on the Fulbright Specialist Roster matched to host institution projects
- 4. Final approval by the J. William Fulbright Foreign Scholarship Board
- 5. Fulbright Specialist implements project abroad with host institution



Fulbright Specialist Program Application Process

• Faculty apply to be named to the Fulbright Specialist Roster. If selected, they are on the roster for a period of 3 years and can be paired with either open projects from host institutions around the world or with a specific project developed by the Specialist with an international colleague and a host institution in advance.

• Faculty can be paired with a Specialist project at a host institution in two ways:

1. Apply to be paired with an **open project** on the World Learning website. Host institutions need faculty with specific expertise to work on projects throughout the world. In open projects, the cost sharing is already supplied by the host country/host institution.

2. Work with an existing international partner and their host institution to develop a specific project and get that project approved and funded by the appropriate host country Fulbright entity or World Learning.

1. Consult with faculty in selecting the right award, contacting Fulbright, or finding host country or host institution contacts.

2. Assist faculty through the application process, including supplying sample applications, sample LOIs, and other useful documents.

3. Review individual application materials of faculty before the September 15 application deadline and in advance of any Specialist roster deadline.

4. Assist faculty through the award and post-award process.





1. **Plan Early and Contact Me**: I have sample project statements, LOIs, and other helpful materials when submitting an application. Contact me at <u>clukasik@purdue.edu</u>

2. Notify Your Department Head and me as soon as you know you will apply.

3. **Apply!** More than half of Purdue applicants for the Scholar Program win an award; the percentage is even higher for the Fulbright Specialist Program.

4. **Help me Raise Awareness and Recruit Faculty Applicants**. Let your colleagues know about my position and about Purdue's new policies, its success in these programs, and the exciting new award opportunities for teaching and research.

5. **Communicate**. Let me know if you apply to Fulbright or when you win an award. Or, alternatively, let me know why you chose not to apply. Are there still faculty disincentives that Purdue needs to address?
