The following list shows items that must contain positive data or legitimately blank (No DK's allowed).

Section A: Tract & Field Characteristics

Items 1a, 1b, 1c, 1d, 1e, 1f or 1g (Acres by category)

Item 2, Total acres in selected field

Item 5, Majority of the acres in selected field

Section B: Conservation Plan

All Allow DK's

Section C: Cropping History and Conservation Practices Item 1

Row a, Crop or Land use code

Row b, Intended use code, if applicable Row c, Acres planted

Row d, Date planted

Section D: Fertilizer Applications

Items 1a, 1b, and 1c

If Item 1 = 1 for any year (Items 1a, 1b and 1c), then cell 0299 must be 0 for the appropriate year, and at least one line must be completed in the fertilizer applications table, unless this section was refused.

Items 11a, 11b and 11c – all three years of the Fertilizer tables

Column 7, Materials Used

Column 9, Fertilizer applied per acre

Section E: Manure Applications

Item 1, Manure applied

If Item 1 = 1, then cell 0599 must be > 0 and must have at least one completed line in the manure applications table, unless the section was refused. For each line of manure reported in the table, columns 1, 6, 7, 8, 9, 12, 13, and 17 must have positive data. (Minus one's allowed in columns 4, 5, 10, 11, 14, 15 and 16.)

(In columns 8 and 13 use '2' for Don't Know; in column 12 use '13' for Don't Know.)

Item 6, Manure applied produced on this operation.

Section F: Pest Control Applications

Item 1 (for each year applied)

Items 10a, 10b and 10c, for each year specified, if Item 1 = 1, then for the corresponding year specific table, cell 0399 must be > 0 and must have at least one completed line in the table, unless the section was refused. For each line of pesticide reported in the table, columns 4, 7, 12, and 13 must have positive data (minus ones allowed in columns 8 thru 11).

Section G: Pest Management Practices

Item 1, How was field primarily scouted for pest (IC1701)

Section H: Irrigation

Completion codes on page 35 will need to be completed if there was no irrigation.

Section I: Field Operations

If field operations are recorded for a particular year (Item code cells 3004, 3003, or 3002 are blank), for each line of a field operation recorded in the table, columns 2, 6, 7, and 8 must have positive data (minus ones allowed in column 9).

Planting and harvesting activity must be reported for each crop if both occurred in the same crop year.

Items 1a, 1b and 1c, for each year with field operations, then for the corresponding year specific table (Tables 100, 200, 300), cell 0499 must be > 0 and must have at least one completed line in the table, unless the section was refused.

Section J: Whole Farm

None required.

Section K: Operator and Operation Characteristics

None required.
