# Conservation Effects Assessment Project (CEAP)

- Conservation focused survey led by Natural Resources Conservation Service (NRCS) and Iowa State University
- Utilizes a soil area frame data base (National Resources Inventory)
- Goal: Quantify trends in agriculture and the impacts of conservation practices
- Scope and impact: regional, national, and watershed scales



### **CEAP Survey Flow**

- Phase 1: Screening for eligibility
  - Include hay pasture and summer fallow fields
  - Exclude orchards, permanent pasture, vineyards, green houses, and nursery crops



## **CEAP Survey Flow**

- Post Phase 1: Sample adjustment
  - Update targets for Phase 2 data collection
    - Non-response, refusals, no items of interest
- Phase 2: Collecting specific field data and production practices
  - Similar to ARMs surveys with fertilizer, pesticide, operations tables
  - Much more focus on conservation practices or lack of practices depending
  - Questions will cover operation management practices during 2022, 2023, 2024 seasons
- Presurvey letter mailed out around July 15th to target operators
- CEAP news releases sent out June 26th for all three states



# Publication

- There will be a highlights publication after Phase 2 data is cleaned and summarized
- NRCS publications will not be released until after the 2026 CEAP cycle data is cleaned and summarized

# **CEAP Assignment Packets**

- Everybody should have already received an Assignment Packet and a Training Folder
- Each CEAP assignment packet will include all materials needed to complete Phase 1
- Phase 2 materials will be handed out at the regional school in November



# **Assignment Packets**

- Labeled Manilla Envelope (One for each NRI Sample Point):
  - FSA Listing
    - Use to take notes for updating target in CAPI
    - Lists individuals registered with FSA during 2023 or 2024 signup periods
  - NRI Point ID label
  - Aerial Map
  - Operator ID Card
  - Blank Screener Form
- The envelope will <u>not be mailed</u> and is for organization and note taking purposes

# **FSA Name and Address Listing**

- Listing of all individuals who registered with FSA in 2023/2024
- Best information to identify operator
  - FSA "BEST GUESS" operator
- High data linkage rate between FSA and NRI
- Operator must be located. Owner may be listed instead, but try and get the operator.



# **FSA Name and Address Listing**

- Remember some points only have operation names referring to a corporation, LLC, JV, partnership, trust
- Please get the name of the primary operator for the operation for overlapping against the LIST FRAME
- FSA Name Type column
  - OP = operator
  - OO = owner/operator
  - OT = other
  - OW = owner



- Operator card is the tool to determine where one person operates multiple points/fields
- During Phase 2 an operator will be surveyed for only one point/field
  - If you have a farmer with multiple points, use the same Operator ID number on all the points that he operates
  - Office will notify you which point goes into PHASE 2
- Reduces respondent burden and duplication



• ID numbers will be used in the NRI screener website (Write down ID Number if working on paper)



• For security purposes the ID is not pre-assigned or linked to the operator



• During Phase 1, ask operator if they received a card from another CEAP enumerator

#### • If Yes:

- ask operator to find operator card and record card number in iPad
- if operator received card but lost it, record 999-999-999 as the card number in the iPad screener



- If No:
  - Provide operator a CEAP Operator ID Card and record number in the iPad screener and on the CEAP envelope
  - Operator should keep the card until November 1, 2024
  - Tell operator to provide the card to other CEAP enumerators if contacted
- Write the ID Card number on the envelope in case the RFO needs to follow-up with the operator
- Tip: Consider writing your name and phone number on back of ID card before giving to operator for follow-up



# **Operator ID Card Review**

- USE THE SAME Unique Operator ID for ALL POINTS
- The Operator ID Card has the unique number
- Write the unique number on the front of the CEAP envelope
  - Might need to reference back to if for duplication
- Only use 999-999-999 in the TRAINING Screener website

- What is confidential for the purpose of this survey?
  - **Location** of NRI sample points found on aerial photographs
  - Information
    - listed on the FSA Name and Address Sheet
    - Reported on screener
  - Aerial Images
  - Personally Identifiable Information (PII)








# Confidentiality

- Personally Identifiable Information (PII)
  - First or last names, nicknames, phone #s, addresses etc.
  - <u>Not</u> allowed anywhere on screener application/NRI website
  - Make sure PII is not in notes






# **CAPI vs Screening Tool**

- What will you use CAPI for?
  - Making updates to operator/operation names, addresses
    & phone numbers
  - Submitting comments with PII

# **CAPI vs Screening Tool**

- What will you use NRI Screener Tool for?
  - Filling out screening questions for assigned points
  - Adding relevant comments when required
  - Note: NRCS will review all comments submitted
  - Drawing off field boundaries for those points when applicable
  - Submitting operator IDs
  - Operator ID # should match the # on operator ID cards →



- Returning points



# **Screening Tool**

#### Before leaving for the field (interview)

- Find a location where you have a wireless internet connection
- Check out all points you plan to screen during the day



# **Screening Tool**

- After returning from the field
  - Open each "Not saved" point to ensure it saves to the server
  - Return all points screened during the day, if not already returned in the field
  - Make sure your points are SAVED, saved to server (green light)
  - Complete interview should be green light when completed
  - Close and Return all points at the end of each day
- You cannot log out until all of your NRI points are returned



# Wrapping Up

- On the initial visit to the operation, you will:
  - Confirm you have located the current operator or knowledgeable person of the sample point.
  - With help of the operator draw off the field boundaries surrounding the sample point.
  - Screen to make sure the current land use will qualify as "cropland, managed grassland (pasture), idle, summer fallow, CRP or CREP"



# Wrapping Up

- Schedule a general timeframe to return to complete the Phase 2 after November 15th.
  - Interview for Phase 2 must be scheduled after harvest of the 2024 crop is complete (After November 15th).
- Present the operator with a CEAP Operator Card and note the number on the screening application.



# Wrapping Up

- Write on the envelope the name, address, and phone number of the person you interviewed. Add directions and any other notes.
- Enter updated target information in CAPI (if applicable)



# **Presentation Highlights**

- Do not enter any PII into the NRI Screening website
  - Refusal and inaccessible situations will need explanations
- CAPI can have PII comments updated to explain a situation when updating target information
- Write the nine-digit NRI code on the envelope for reference after submitting on the NRI website



# **Presentation Highlights**

- Do not mail blank Phase 1 questionnaires back to the office
  - Hold on to the paperwork until the CEAP Phase 2 school
  - Use the blank questionnaire to take notes during the interview
  - All data collected during Phase 1 Screening is entered exclusively on NRI Screening Instrument through your iPad
- Visit the GLR NASDA website for referencing CEAP videos, documents, NRI help documents, training PowerPoints
