(Freight on Board) shipping point price, or equivalent, for all grades and qualities sold for fresh market. The F.O.B. shipping point is a point of first sale. Equivalent points of first sale include farm, roadside, farmer's market, grower auction, and U-pick sales. Adjust sales at wholesale terminal markets for freight, brokerage, and commission charge paid by the grower.
