

CAPI Update – Morris

New versions of CAPI production and CAPI training applications will be automatically pushed to all active CAPI iPads during the day on Saturday. Enumerators must logout of CAPI by 9:00pm EDT on Friday, September 23, 2022. Please note that CAPI will be unavailable for use between Friday, September 23 after 9:00pm EDT until Monday, Sept. 26th at 6:00 AM EDT. The following fixes include:

• Fix issue with enumerators with large assignment listings not being able to log-in to CAPI.

The new CAPI application version will be <u>V22.09.24</u>. This is an <u>automatic push</u>. All Enumerators should log out of CAPI by time stated above, and have their iPad fully charged or plugged into the charger. If the auto-push fails for some reason, enumerators will need to go to Apps@Work on their iPad and manually install both updated CAPI applications. We will also post a note on the CAPI dashboard. All enumerators should do "Clear Preferences" on the CAPI login screen before logging back into the green mobile CAPI icon. Vegetable Chemical Use Survey Update – Goings/Tolbert

This year HQ has pushed back the dates for the Vegetable Chemical Use Survey (VCUS). Data collection will start on November 1st and end on December 30th. We will be sending out a portion of high impact records for Face-to-Face Interviews. The other records will be collected via phone.

Enumerators working VCUS will receive one questionnaire for training purposes with the October 1 Survey Materials. All additional materials, such as interviewer manuals, will be included in the November 1 UPS packages. The separate mailing is necessary due to the later start date and printing of materials by HQ. Previously, enumerators were asked to submit all records via CAPI. However, this year only Out-of-Business, Out-of-Scope, Refusals, and Inaccessible records will be submitted. **All completed records, including questionnaire supplements, should be sent to the NOD for keying.** All enumerators will be provided UPS labels to send those forms to the NOD in their November 1 UPS packages. The last date to mail to the NOD is December 30th.

Procedures for completing the MDARD Recertification Record (i.e., the "bubble sheets") for those respondents wishing to take advantage of the two restricted use pesticide (RUP) applicator credits will remain the same as 2021. Respondent signatures are still not required on the bubble sheets themselves; but all of the other information asked for on the bubble sheets must be collected from the operator during the interview, including the operator's name as it appears on the applicator license, the applicator number, the type of certification, and the type of credits they need. Information from the bubble sheets will continue to be sent to the Regional Office in East Lansing, where it will be compiled into a spreadsheet and sent to MDARD. Please reach out to your supervisor if you have any questions on completing the MDARD records. If you have any questions or concerns on VCUS, please reach out to the NASDA Coordinator.
