Ag Yield and Potato PDI: – Collom

Just a reminder that November 1 Ag Yield and Potato PDI are both due Sunday night by 11:59 pm. Harvest has been challenging this fall and we're hearing that soybean yields are being affected by white mold in some areas, so this month's Ag Yield is important. Please do your best to get reports from those farms assigned to you and get those reports entered into CAPI by Sunday night.

ARMS II and FCUS – Weber, Goings

First, thank you all for your hard work on these surveys and all the surveys currently underway. We realize, especially for Soybeans ARMS II, that contacting operators during peak harvest is no easy task. We wanted to share the national return rate for FCUS, Oats ARMS II, and Soy ARMS II in the table below as of November 3rd. I included other Midwest states to see how we compare when looking 'apples to apples'. The numbers speak for themselves – we are doing well in some spots, and not so well in others. It appears to be tough to get data all around the Midwest – particularly for soybeans. HQ still wants to encourage us to send in 50% of good, completed forms by November 8th for ARMS II and by December 9th for FCUS— which we can all see is quite a challenge. At the very least, please get appointments on the books to collect data with enough time to send complete reports back to the NOD (Nov. 30th last day to ship for ARMS II, Dec. 29th for FCUS). I also want you to know that your efforts don't go unnoticed, here in the office and in HQ – so please keep up the good work – and please ship your forms back early and often as every form helps to push us ahead of the rest of the pack. <u>Veteran's Day Holiday – November 11</u>

The Regional Field Office will be closed this Friday, November 10, in recognition of Veteran's Day. This federal holiday is celebrated every year on November 11, regardless of the day of the week it falls on. First recognized as Armistice Day in 1919, Veterans Day marks the date when Germany and the allies signed a 1918 agreement to cease World War I hostilities. The fighting ceased on the 11th hour of the 11th day of the 11th month, according to the Department of Veterans Affairs. President Woodrow Wilson proclaimed November 11 as the first commemoration of Armistice Day, saying: "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory." In 1938, Congress passed a law to mark November 11 as a legal holiday. In 1954, President Dwight Eisenhower signed a law that changed the name to its current form.
