NAHMS Sheep Study Follow-Up - Hiegel/Courser

As mentioned in a previous Friday Feedback, the NAHMS Sheep 2024 Study is being administered by NASS and the National Animal Health Monitoring System (NAHMS) in order to compile important information about the sheep industry. The main data collection period ended last month, but in order to improve response rates, a follow-up phase will be conducted. The tentative time frame for this follow-up period is late March through early April. Field visits and local phoning will be the primary methods of data collection (although respondents will still be able to report online and by mail).

Producers that have yet to respond to the study will be assigned to a select group of enumerators. Further details will be communicated to these enumerators as it becomes available. Survey materials will be posted to the Purdue site and will be included in the April survey packets. If you have any questions or concerns about the study, please contact your supervisor, NASDA Coordinator, or the Regional Field Office.
