Ag Yield – Collom

Ag Yield enumeration ends on Sunday at midnight. Please make every effort to contact your outstanding assignments a few times before then. This survey will be used to update projected wheat yields and set the initial projected yields for oats (MI/OH) and barley (MI-published in ‘other states’). The Crop Report containing projected yields will be released on Friday, July 12 at noon.

Data collection for these surveys will begin on July 29 and conclude on September 27. Data will be collected on paper and then enumerators will enter the data into their CAPI instruments. iPadOS 17.5.1 Approved - Morris

The current iPadOS (17.5.1) is approved to run on all CAPI devices. Please have all enumerators update to this new iPadOS by Friday, July 26, 2024.

A good cellular connection and/or WIFI is needed for a speedier install. Also, enumerators need to have their iPad fully charged before attempting to install this iPadOS. Expect the install to take ample time to complete. We will also post an approval message on the CAPI Dashboard to assist with notifying enumerators.

Lastly, with iPadOS 17.5.1, a new feature was added with this update that needs to be disabled. It is called the “Rapid Security Response.” To disable this feature, go to “Settings” → “General” → “Software Update” → “Automatic Updates.” Once there tap the slider next to “System Responses & System Files” to turn it from green to gray. That will disable the features. Also, double check that “Download iPadOS Updates” is also disabled by taping the slider from green to gray.

Please use your enumerator id as your username and your official NASDA email when registering for an account. Accounts that do not follow these guidelines may not be approved.
