PRESCREENING PRACTICE EXERCISE – RUSHVILLE, IN 46173

The follow scenarios describe what one might find while completing prescreening for a <u>brand new segment</u> in Rush County, IN. The six tract operators listed below will correspond to the segment photo for Rush County from the Gridding Exercise. Use the information provided to complete the screening form and any necessary ag tract questionnaires on paper. You can even use this information as the basis for conducting mock interviews with a partner over the phone before pre-screening begins.

Once you have entered all of the data onto a paper form, you should enter this data into one of the new segments available in your CAPI Training Listings so that you can become familiar with that process. If you do not have any new segments in your CAPI Training Listings, then you can use one of your old segments.

ALVIN A lives 200 Southside Road in Rushville Indiana. Phone Number is (111)-111-1111. Looking at the parcel map, he owns parcels 1 and 12, but he rents out parcel 12 to Bonnie B. Alvin A is retired. He no longer actively farms any land, he raises no livestock, he owns no horses, and does not receiving any government payments. He has no plans to get into agriculture ever again. His homestead (Parcel 1) is about 1.2 acres in size and would be considered "residential" (code 1 in column 20a).

BONNIE B lives at 300 Westside Road in Rushville Indiana. Phone Number is (222)-222-2222. Bonnie lives just outside the segment boundary at the farm house just across the road from what appears to be the boundary between parcels 2 and 3. She tells you that she operates parcels 2, 3, and 12, but not the woods in the middle of those three parcels, as those are managed by Rush County. All together, they operate approximately 194.5 acres inside the segment. Bonnie, in partnership with her two sons BILLY B and BOBBY B (who live at the same address) raise corn, soybeans, and wheat both inside and outside the segment. They also raise hogs under contract for EVAN E but do not own any hogs themselves.

CHARLES C Lives at 250 Northside Drive, Rushville Indiana. Phone number is (333)-333-3333. Charles lives in Parcel 7, but also farms all of parcels 4, 6, and 8. He has nothing to do with the woods that are bounded by parcels 8, 11, and 3. Charles and his wife CELIA C are a two-person partnership that owns and operates 80.5 acres exclusively inside the segment. On the 80.5 acres, they grow corn and grass hay, and raise some cattle for beef. They do have a storage capacity that can hold up to 15000 bushels of corn, but the bins are empty at this time.

DANIEL D lives at 350 Northside Drive in Rushville Indiana. Phone Number is (444)-444-4444. Daniel and his wife DEE D, who is not a partner in the farming operation, live in parcel 9. He also operates parcels 10 and 11, but not the 20-acre field in the southeast corner of parcel 11 that is bound to the east by the segment boundary and bound to the west by Parcel 12. That 20-acre field is rented out to EVAN E. All together, Daniel estimates there are 100 acres operated inside the segment, on which he produces corn for silage (all planted), soybeans, and alfalfa. Daniel also raises dairy cattle, all outside the segment.

EVAN E Lives at 500 Outside Lane in Rushville Indiana, Phone Number is 555-555. He confirms to you that he does operate the field that is the part of parcel 11 to the east of parcel 12, which will be planted to corn for grain, and maybe he could get it all planted by the end of the day IF he didn't have to be on the phone with you. He confirms that he does own hogs that are being raised under contract by Bonnie B and her sons, but he has no time to complete anything else right now and hangs up on you. (assume you are not able to contact him again before the survey is over).

The **Rush County Parks and Recreations Board** is responsible for the woods that are all marked with Parcel 5 and the open area in the southeast corner of the segment that does not have a parcel number associated with it. There is no agricultural potential in these woods, and the open ground in the southeast corner of the segment is just a public park with no ag activity.

For the purposes of this exercise, the size of Tract F will depend upon the size of the practice segment you are playing with in CAPI. In column 18, record the number of acres needed to bring the total acres of the tract up to the total digitized acres so that you will be able to submit your test segment without any errors.
