## **EDR Survey Code Discrepancies – Courser**

We recently became aware of an issue in the Labor CAPI instrument where some of the Respondent Survey Codes (EDR Survey Codes) are in error when viewing them in the "info" icons in CAPI. The codes printed on the mailing labels for questionnaires sent directly to respondents should all be correct. The codes displayed in CAPI for POIDs starting with 7, 8, or 9 are correct, but the codes for POIDs starting with 1 or 3 may not be correct. For now, please do not provide survey codes from CAPI for respondents to use in EDR on the AgCounts website. Please note that while we discovered this problem on the Labor survey, it does appear to be a problem with other CAPI surveys as well. Fixing this problem is going to require a new CAPI build, which will be pushed out once the issue is resolved and tested. The tentative date for the new build and push is November 15, 2021. Thanks to everyone for their patience.

# Chem Use Survey Odds and Ends – Miyares/Weber/Goings

We've gotten through nearly one month of data collection, and we are slowly making progress! By now, we're hoping that everyone has contacted their sampled respondents to set up an interview time or identified reluctant respondents who may require possible refusal conversion. We were also hoping to see at least one report submitted in CAPI by everyone, even if that report was a refusal. Please be sure your supervisors are aware of your progress with these surveys.

We have received several reports regarding text values not "sticking" in the Field Operations table in the ARMS II CAPI Instrument. We certainly understand your frustration with this. Our HQ has been working on this problem and they are working on a fix for it. Thank you for your patience as we go through some growing pains with this instrument.

We're starting to see people report chemicals for which there is not a product code available. Remember that in CAPI you can submit the information about the unknown chemicals as part of Question 2 in Section D. Keep in mind that if you keep seeing this same new chemical over and over and want to see if there is a new product code available, first check under the links for the "New Chemical Codes" on either the ARMS II or FCUS pages. If the code isn't available, you can reach out to either Paul Goings, Ben Weber, or John Miyares for more information. In some cases, we just need to request a new code be created, and within a few days, it will become available for use.

Have you run into respondents who say they'll work with you on the survey, but they lost (or never received) their copy of the form in the mail? The office has a stack of respondent mailers ready to go at a moment's notice. Just contact either your NASDA Coordinator or one of the stats in charge of the Chemical Use Surveys (John, Paul, or Ben W.), and we can have a new form sent to the respondent within a day.

## **Ag Yield Reminders – Price/Miyares**

We are reaching the end of this year's Ag Yield season. Thanks to everyone for their hard work on this survey this year.

Some operators may push back on the survey, asking why they keep getting contacted every month. The Ag Yield survey is conducted monthly throughout the year in order to track expected yields based on changes in weather, soil, and crop conditions. A crop that looks good one month based on adequate heat and timely rains could decline in quality based on overly dry or overly wet conditions taking place over the four-week period between surveys. Major weather events such as floods, hurricanes, and tornadoes can also affect whether a field can be harvested. High moisture in the grain or disease contaminants may change what the farmer is able to sell at the end of the season. NASS publishes updated expected yields in the monthly *Crop Production* reports, which come out on or before the 12<sup>th</sup> of each month. The November Survey represents that last time this year that these operators will be contacted to provide a forecast for their corn and soybean crops.

Although none of the operators in the Monthly Ag Yield sample will be included in the December Crops APS survey, nearly all of them will be included in the Row Crop County Agricultural Production Survey (aka. Row Crop CAPS). The CAPS will be mailed out next month, with follow-up phoning to take place in December and January. When contacting operators for Ag Yield this month, please remind them that they may receive one more survey next month to confirm their final corn and soybean yields for the season.

Occasionally, we have some operators in the November Ag Yield survey tell us that they didn't have any corn or soybeans to harvest this year. If this situation arises, please take detailed notes to explain the situation. Operators in the November Ag Yield sample would have told us in June that they were planting corn and/or soybeans, and most likely would have reported expected yields to us at some point between August and October. If something changed, or if we've had it wrong all along, we need to know what happened.

## **ARMS 2 Odds and Ends – Miyares**

The CAPI Instrument for ARMS 2 is back up and running after being taken down temporarily yesterday, October 21. We're not sure at this time what the problem was but remember that there is now a way to easily report problems with the CAPI instrument on the Purdue GLR Home Page. We will relay these issues to our headquarters as they are reported to us.

As a reminder, if a respondent is unable or unwilling to answer large portions of the questionnaire, don't feel the need to enter "DK" for every cell. In most cases, it will be okay to leave the cells blank and leave a comment in CAPI to indicate that certain pages were skipped.

There are, in fact, some questions where "DK" is not allowed. One place in particular where cells should be left blank of the operator doesn't have an answer are the FSA Farm, Tract, and Field numbers in Section A, Question 5. If a respondent doesn't know this information, please leave the questions blank instead of putting in DK in those cells. If you have questions about where to put "DK" and where not to, check with your supervisor.

## **Sad News**

We are seeing that we do have some completed ARMS II forms already throughout the region, which is very encouraging at this point. A question was raised about Section A, Question 1b regarding "Conventional Corn". For the purposes of this survey, "conventional corn" will be <u>non-organic</u> corn, and could potentially include GMO/GE corn varieties. Consequently, the sum of the planted acres in question 1b should equal the total planted acres in question 1, and the number of planted fields in question 1b should equal the total number of fields planted in question 2.

A few weeks ago, we reported that there would be a new tool available for reporting problems with CAPI instruments. This tool is now LIVE and can be found at this <u>LINK</u>. There is also now a link to this form on the Purdue GLR Home Page. Essentially you would provide the survey name, the POID, the section and question number, and a description of the problem. The message will be passed on to the stats in charge of the survey and, as needed, passed onto the CAPI development team at NASS headquarters.

## **ARMS II Odds and Ends – Miyares**

After some initial delays the CAPI Demonstration Video is now available on the ARMS II pages of the Purdue GLR website. It is about 60 minutes in length, and an index was included at the beginning to make it easier navigating to topics of interest.

There has been one significant change to the layout of the CAPI Instrument since the CAPI Demo video was published. A problem was discovered with the Section F Field Operations Table where equipment names entered in the table were not "sticking" when the record was either submitted or saved for review. In order to fix this, the table had to be reordered so that the equipment name became the first column and the sequence number was moved to the third column. Please pay attention to this difference as you are entering numbers into CAPI.



A question arose at a mini-school regarding the Section F table and whether to include hauling activities by semi-trucks if those trucks do not enter the field. While the field operations table helps ERS analyze the impacts of soil compaction in the field by tracking the amount of machinery entering the field, the table is also used to determine the cost of production of the target crop. Since hauling is one component of that cost, we DO want to include semi-trucks involved in hauling the crop to the point of first sale, even if the trucks do not enter the field.

## June Area Photo Update - Miyares

As of Thursday morning, October 7, there were still 171 June Area Photos in Indiana and Ohio that have not yet been returned to the office. These are past due. Please work with your supervisors to have them returned to the Regional Office as soon as possible.

#### **Objective Yield – Erickson**

Thanks for your hard work so far with Objective Yield. The 'Crop Production' Report will be released on October 12, which will contain yield & production estimates, including corn and soybeans. Data collected for Objective Yield & Ag Yield were used to prepare these estimates.

Please monitor your fields closely. Even though the November 1 data collection period doesn't officially open until October 25, you must conduct a final visit when the crop is mature, or a few days prior to when the farmer intends to harvest the sample field. So, a final visit may take place at any time. For example, if a final visit is done on October 14, please fill out the final Form-B with the fieldwork date of October 14. The date on the id cards that are sent to the lab along with the sample, should also be October 14. The sample should promptly be sent to the lab in St. Louis, and the Form-B should be held until CAPI is open for the November 1 survey.

CAPI for the November 1 survey (Form-B) will be open on October 22. If you conducted a final visit earlier in October, such as the example above, please submit this final Form-B on October 22. Samples that have already been completed will not be populated to the iPad for the November 1 survey.

CAPI remains open for the Objective Yield Form-A's, because there are still a few OY respondents who remain inaccessible. The Form-B for these will be populated to the iPad for November. Even though it is unlikely at this point, if a Form-A is completed and the sample field has not been harvested yet, please go ahead and submit the completed Form-A and lay out the units, as usual.
