We appreciate your hard work on this year's Corn and Soybean OY surveys! Thank you for diligently inputting for your Form-A entries into CAPI. Form-A interviews may be attempted as needed throughout the survey period and should NOT be submitted as inaccessible. If someone is still inaccessible on November 1, please submit the Form-A as a refusal at that time. Please continue to carefully and accurately enter the date and status codes in CAPI.

You probably noticed that the Form-B's were populated to the iPad last week. This was done to allow you some extra time to submit the Form-B for refusals and lost samples. So, for refusals and lost samples, please submit the Form-B as well, using the same status code that you used for the Form-A.

Fieldwork for this month began on Thursday, August 25 and will continue through September 1. Data entry within CAPI for September Form B will remain open through Friday, September 2. As you spend time laying out corn and soybean fields, we want to remind you to monitor yourself for signs of physical fatigue and dehydration. Please prudently review the safety precautions related to potential pesticide applications which are noted in the Interviewer's Manuals. Thank you!







If you speak to a grower who tells you they are growing hard red or hard white winter wheat, please probe further to verify what is being reported and leave comments in CAPI to explain the situation.

Enumeration should begin immediately with completed questionnaires shipped back to the office no later than September 1. Refusal and inaccessible records can be entered via CAPI.

# Push back of Small Grain CAPS Start Dates - Hendrixon/Tolbert

This year we will return to face-to-face interviews for the Small Grains Survey. This however will require we push back data collection to ensure the budget can support data collection efforts for the entire calling period. New data collection dates have been updated on the <u>3-month calendar</u>. Our preliminary plan is to start data collection with anticipated matches with September 1 Surveys, including Hogs, Turkeys, Crops APS, or September Ag Yield, around August 30. ## **Dealing with CAPI Outages – Tolbert**

Over the last two weeks, CAPI outages have been interrupting data collection. The outage brought up questions about how best to deal with that situation, especially if it occurs on a weekend when Regional Office staff aren't working. Here are some possible options to try:

- Use your desktop to access the **Ag Counts** page to enter data.
- Try going to the <u>CAPI Dashboard</u>, which may also have information on the problem and the estimated time to get things back up and running

If after troubleshooting you are still having problems, then you can try contacting your supervisor or your NASDA Coordinator. Remember, the office will not penalize you for not working when CAPI is down. Keeping CAPI running is NASS's priority and responsibility. We thank you for your continued patience and understanding.
