Ag Yield/Potato PDI - Collom/Presberry/Dothage

Ag Yield and Potato PDI (Michigan only) enumeration begins this Wednesday, October 30 and continues through Sunday, November 3. The data collection period is very short this month, shorter than normal. Please don't wait to begin data collection. This is the final month for Ag Yield. Corn and soybean yields will be forecast in all 3 states.

Use CAPI DASHBOARD for CAPI Applications (not the red/green icons on the iPad) - Morris

A security concern was identified at the Department level requiring NASS to update the CAPI applications. MSS will procure a fix and push a new code to only the CAPI production and CAPI Training URL applications at this time (located in CAPI DASHBOARD). This will enable NASS to begin to comply with the security update. This will be a URL only push, and it is scheduled to begin late **Friday, October 25, 2024**. Enumerators will not notice any changes to CAPI.

Starting **Monday, October 28, 2024**, enumerators should discontinue using the CAPI mobile application icons on their iPad and begin using only the URLs to access CAPI Production or CAPI Training. They should use the links located on the CAPI Dashboard to access regular CAPI and the CAPI Call Pooler. They can use the iPad or a Desktop. We will schedule a separate push for the CAPI mobile application icons on the iPad sometime in November.

The new version number for the CAPI applications will be released on the CAPI Dashboard. Full enumerator instructions should be posted to the CAPI Dashboard before COB on Friday, October 25, 2024. It is possible that enumerators will need to clear history on their desktop browser (Chrome) or on the iPad (Safari) to see the new version display inside CAPI. Update Your iPad to iOS version 18.0 – Morris

The current iPadOS (18.0) is approved to run on all CAPI devices. Please have all enumerators update to the new iPadOS 18.0 before **Monday, November 4th** (or at least before Apple pushes out a new version). Please do not update to any other version except 18.0. A good cellular connection and/or WIFI is needed for a speedier install. Also, enumerators need to have their iPad fully charged before attempting to install this iPadOS. Expect the install to take ample time to complete. Lastly, with every iPadOS update – sometimes some features ("System Responses & System Files" and "Download/Automatic iPadOS Updates") will turn ON – please check and make sure these are OFF. To disable this feature, go to "Settings" \rightarrow "General" \rightarrow "Software Update" \rightarrow "Automatic Updates." Once there tap the slider next to "System Responses & System Files" to turn it from green to gray. That will disable the features. Also, double check that "Download iPadOS Updates" is also disabled by taping the slider from green to gray.
