- Deputy Updates
 - Management Budget Update
 - Training no extensive, in-person training.
 - 20% reduction in regional June Area Budget.
 - Program cancellations for 2024: Cotton OY, July Cattle, County Estimates (Row Crops and Small Grains).
 - Highly Pathogenic Avian Influenza (HPAI) update and visiting operations guidelines.
 - Poultry and Cattle so far large depopulation of birds/layers.
 - March 29 MI stated first dairy herd tested positive.
 - Week of 4/8 3 more dairy herds tested positive in MI.
 - 8 total states w/ reports in dairy herds.
 - 1 case recently reported in OH (cited in Farm and Dairy https://www.farmanddairy.com/news/ohio-dairy-herd-tests-positive-for-highly-pathogenic-avian-influenza/819217.html)
 - Some groups limiting livestock movement between states
 - Dairy herds can recover much better than poultry operations.
 - Limiting number of personnel on operations.
 - Since milk is pasteurized, not concerned for public health in terms of dairy
 - What does that mean for us?
 - Shouldn't visit large poultry/dairy operations try by phone first.
 - If you do have to visit, park far away from animals.
 - Keep distance from livestock.
 - Utilize any foot sanitizing baths or boots (PPE).
 - We have a limited supply of boots in the regional office please request through Purdue Site.
