- **Survey Updates - Adam/Mike**

- Timeline of large survey projects - similar to last month, will be brief
- Now
 - August 1 Corn and Soy OY
 - **Train the Trainer (Supervisor OY Meeting) - July 24th 10 AM - 12 PM Eastern**
 - **Mini schools** (IN and OH) have all been scheduled
 - Plan to ship packages to supervisors by ~~July 19th~~ **July 15th**
 - Individual packages shipped to enumerators by **July 18th**.
 - CEAP (CONSERVATION EFFECTS ASSESSMENT PROJECT)
 - Make sure your enumerators that are working CEAP create or reactivate their account (see CEAP page on Purdue Site for details)
