- 17. Donnie D lived and farmed in Tract D last year, but passed away in January 2024. Donnie's widow tells you during prescreening on April 15 that the land is currently idle and they are hoping to find a renter before June 1. Prescreening is about to end. What should you enter in the screening form in CAPI? Choose all that apply.
 - a. Leave the tract in Donnie's name because there isn't a new operator yet.
 - b. Mark Donnie as "No Longer in Segment" by answering "No" to the first question.
 - c. Create a new tract letter for the new operator and use the name "Unknown Operator"
 - d. Create a new tract letter and enter Donnie's Widow as the new operator.
 - e. Wait until June to determine who the new tract operator is and enter it into CAPI then.
